Quality Payment Program APMs: Update Billing Information by November 13

Many Qualifying Alternative Payment Model (APM) Participants (QPs) got 2020 5% APM incentive payments last month. Some clinicians need to update their Medicare billing information by November 13 to get paid.

Do You Need to Verify Your Medicare Billing Information?

- If you didn't get paid, find your name on the <u>spreadsheet</u> to find out which form(s) to send us. Log in to the <u>QPP</u> website using <u>your HARP credentials</u> to update your billing information; see <u>detailed</u> <u>instructions</u>.
- If you got paid, you don't need to do anything.

Hospice Aide Services: Enhancing RN Supervision

An Office of Inspector General (OIG) report found that Registered Nurses (RNs) didn't always:

- Visit hospice patients' homes at least once every 14 days to assess the quality of care and services provided by hospice aides
- Document these visits as required
