I. GENERAL INFORMATION

A. Background: The ASP methodology is based on quarterly data submitted to the Centers for Medicare & Medicaid Services (CMS) by manufacturers. CMS will supply the contractors with the ASP and Not Otherwise Classified (NOC) drug pricing files for Medicare Part B drugs on a quarterly basis. Payment allowance limits under the Outpatient Prospective Payment System (OPPS) are incorporated into the Outpatient Code Editor (OCE) through separate instructions that can be located in chapter 4, section 50 of the Internet-only Manual.

B. Policy: This recurring update addresses the following pricing files:

File: October 2022 ASP and ASP NOC -- Effective Dates of Service: October 1, 2022, through December 31, 2022
