

# **FRAMEWORK FOR THE ANNUAL REPORT OF THE STATE CHILDREN'S HEALTH INSURANCE PLANS UNDER TITLE XXI OF THE SOCIAL SECURITY ACT**

## **Preamble**

Section 2108(a) of the Act provides that the State and Territories \*must assess the operation of the State child health plan in each Federal fiscal year, and report to the Secretary, by January 1 following the end of the Federal fiscal year, on the results of the assessment. In addition, this section of the Act provides that the State must assess the progress made in reducing the number of uncovered, low-income children. The State is out of compliance with SCHIP statute and regulations if the report is not submitted by January 1. The State is also out of compliance if any section of this report relevant to the State's program is incomplete.

To assist States in complying with the statute, the National Academy for State Health Policy (NASHP), with funding from the David and Lucile Packard Foundation, has coordinated an effort with States and CMS over the years to design and revise this Annual Report Template. Over time, the framework has been updated to reflect program maturation and corrected where difficulties with reporting have been identified.

The framework is designed to:

- A. Recognize the ***diversity*** of State approaches to SCHIP and allow States ***flexibility*** to highlight key accomplishments and progress of their SCHIP programs, **AND**
- B. Provide ***consistency*** across States in the structure, content, and format of the report, **AND**
- C. Build on data ***already collected*** by CMS quarterly enrollment and expenditure reports, **AND**
- D. Enhance ***accessibility*** of information to stakeholders on the achievements under Title XXI.

## **SECTION II: PROGRAM'S PERFORMANCE MEASUREMENT AND PROGRESS**

This section consists of three subsections that gather information on the core performance measures for the SCHIP program as well as your State's progress toward meeting its general program strategic objectives and performance goals. Section IIA captures data on the core performance measures to the extent data is available. Section IIB captures your enrollment progress as well as changes in the number and/or rate of uninsured children in your State. Section IIC captures progress towards meeting your State's general strategic objectives and performance goals.

### **SECTION IIA: REPORTING OF CORE PERFORMANCE MEASURES**

CMS is directed to examine national performance measures by the SCHIP Final Rules of January 11, 2001. To address this SCHIP directive, and to address the need for performance measurement in Medicaid, CMS, along with other Federal and State officials, developed a core set of performance measures for Medicaid and SCHIP. The group focused on well-established measures whose results could motivate agencies, providers, and health plans to improve the quality of care delivered to enrollees. After receiving comments from Medicaid and SCHIP officials on an initial list of 19 measures, the group recommended seven core measures, including four core child health measures:

- Well child visits in the first 15 months of life
- Well child visits in the 3rd, 4th, 5th, and 6th years of life
- Use of appropriate medications for children with asthma
- Children's access to primary care practitioners

These measures are based on specifications provided by the Health Plan Employer Data and Information Set (HEDIS®). HEDIS® provides a useful framework for defining and measuring performance. However, use of HEDIS® methodology is not required for reporting on your measures. The HEDIS® methodology can also be modified based on the availability of data in your State.

This section contains templates for reporting performance measurement data for each of the core child health measures. Based on your recent performance on the measure (from FFY 2005 through 2007), use a combination of expert opinion and “best guesses” to set objectives for the next three years. Please explain your rationale for setting these objectives. For example, if your rate has been increasing by 3 or 4 percentage points per year, you might project future increases at a similar rate. On

the other hand, if your rate has been stable over time, you might set a target that projects a small increase over time. - Quality of service delivery

- Number of SCHIP population served
- Recommendations for program expansion

The measuring and reporting tools indicated the following:

a need to increase the number of Early Interventionists,

a need to expand provider enrollment,

family participation is vital to any early interventions,

a need for an improved child find program

#### Developmental Evaluation Centers (DEC)

1.Annual reports from the three DECs provide data on outcomes, range of services, the level and quality of services, number of recipients (SCHIP, et al).

2.Annual meetings with DECs and DHHS provide forum for policy and procedures updates and address provider concerns.

3.Revised QA tools provide appropriate accounting of compliance to program standards.

4.Modified criteria for Staff Qualifications increased number of sub contractors.

5.Waiting lists and expanded identification sources.

The Initiatives and reporting tools indicated the following:

Requests for DEC services increased considerably

Length of time on waiting lists decreased

Outcomes measurements based on new requests and expanded identification sources

#### Behavioral Health Services (BHS):

1.BHS monitors the programs provided for quality of care and treatment.

Expected outcomes include providing children with emotional/behavioral problems and/or children who have been abused/neglected with:

·Individualized services that meet the needs of each child.

·Quality service delivery that reflects knowledge of the particular treatment issues involved.

·Progressive improvement and relief from symptoms.

·Services designed to keep families together by preventing placement of a child into the foster care system, juvenile justice or an out-of-home therapeutic placement.

·Continued client and family satisfaction.

·Services provided in the least restrictive environment.

Programs report annually on how they meet target outcomes such as:

·For a one-year period after discharge, at a minimum 80% of the children reside in the home of family or a consistent stable caregiver.

·For a one-year period after discharge, at a minimum 80% of the children attend school, job training, or are employed.

·For a one-year period after discharge, at a minimum 85% of the children are free from abuse and/or neglect.

·For a one-year period after discharge, at a minimum 80% of the children avoid involvement with the criminal justice system.

·For a one-year period after discharge, at a minimum 85% of the children do not return to MHS-NOS or a more restrictive level of service.

·At the time of planned discharge, at a minimum 90% of children will have achieved at least 75% of the goals/objectives on their treatment plans.

·At a minimum, 75% of family responses indicate satisfaction with services.

·At a minimum, 75% of referring agencies indicate satisfactions with services.

### 3.Community-Based Wrap-around Services (WRAPS)

Agencies must summarize the program and client outcomes including the number of children receiving WRAPS, their ages and which components of WRAPS they received. This data is analyzed to determine whether or not the WRAPS interventions have an impact on the child's stability in the home and school.

### 4.Psychosocial Rehabilitation Services (PRS)

Programs report annually on how they meet target outcomes such as:

·After discharge, at a minimum 90% of the children that were enrolled in PRS will have achieved at least 75% of the objectives on their treatment plans.

·At a minimum, 75% of children who have been discharged are residing with a consistent, stable caregiver/family for at least three months following discharge.

At a minimum, 75% of children and families indicate satisfaction with the PRS program

·The child's attendance in the PRS program is improved over the child's attendance in his or her previous school placement. The child's unexcused absences shall decrease by, at a minimum, 50%.

·For those children returning to a less restrictive school environment, at a minimum 80% will experience at least 50% fewer suspensions and disciplinary actions than before their enrollment on PRS.

·For those children not returning to the public school system because of age, at a minimum 50% will be engaged in at least one of the following:

1.Completion of their GED.

2.Vocational training.

3.Gainful employment.

·For those children discharged from the PRS program, at a minimum 80% will not return to PRS or a higher level of care within six months from the date of discharge.

### 5. Therapeutic Behavioral Services

Programs report annually on how they meet target outcomes such as:

- After discharge, at a minimum 80% of children are residing with a consistent, stable caregiver.
- For children enrolled in regular day care or school after discharge from the TBS program, 80% will remain in the regular setting for at least one year. For children not enrolled in regular day care or school after discharge from the TBS program, 80% will not return to TBS or a higher level of care for at least one year.
- At a minimum, 80% of children and families indicate satisfaction with the TBS program.
- After discharge, at a minimum 90% of the children that were enrolled in the TBS program will have achieved at least 75% of the objectives on their treatment plans.

#### School Based Services:

1. Access is measured by our annual access to care report of utilization figures broken out by county to capture specific data as it relates to school-based beneficiaries. Also, Medstat allows us to specifically identify beneficiaries and their utilization of Medicaid services
2. Rehabilitative Therapy Services has solicited input from providers to promote program enhancement and to increase provider enrollment to better serve the population.

#### Dental Services:

Monitor the number of enrolled providers, their location and their participation level to determine the ration of dentists to beneficiaries for purposes of access to care needs. Review utilization data by county through the Oral Health Coalition to determine counties that have under utilization of dental resources available.

#### Transportation Services:

Working with advocacy groups and community-based organizations, the brokers and the provider to identify and address areas with barriers to transportation services and determine the source of those barriers. Developing strategies to increase access to care, quality and outcome of care through education of providers and education of parents/caregivers to the resources that are available.

#### Early Intervention

### OUTREACH

DHHS has established contracted partnerships with several entities, both public and private, in an effort to educate our population on accessing and maintaining medical coverage and managing their coverage to ensure quality health care. These efforts additionally identify potential eligibles who have lost coverage, and assist them in obtaining coverage. For example:

DHHS has contracted with Maximus to serve as the state's managed care Enrollment Counselor Service. The Outreach and Education component will develop and implement an overall outreach strategy. Challenges and barriers facing the public will be identified and addressed to encourage the uninsured to apply for, obtain and maintain medical coverage.

What methods have you found most effective in reaching low-income, uninsured children (e.g., T.V., school outreach, word-of-mouth)? How have you measured effectiveness? **Would you consider this a best practice? [7500]**

Making the applications available from commonly visited locations and getting applications into the hands of parents of potentially eligible children has been most effective. South Carolina has a simplified application, which is reader-friendly and simple to complete. The application offers a toll-free telephone number where potential recipients can get assistance and an address where the application can be mailed. However, the requirement of original documents for proof of citizenship puts a damper on the mail-in application process.

With the inception of the program, South Carolina concentrated on building numerous partnerships with organizations at the grassroots level. These organizations participated enthusiastically and effectively in identifying potentially eligible children, making sure their parents received an application and assistance with completing the application.

Currently we do not have an outreach effort, but plan to expand SCHIP in 2008.

At the eligibility level of 150% of poverty, crowd-out is not a particularly worrisome concern. If an income eligible family has health insurance at the time the application is submitted, the children are eligible under Title XIX rather than Title XXI. Even if there is health insurance, the benefit structure is usually inferior to Medicaid in providing such things as well child care and screenings for vision, hearing, and developmental progress. South Carolina does not want to encourage families to drop existing coverage in order to be eligible for more comprehensive services and prefers to provide wrap around coverage to supplement existing benefits.

The application asks for information about any health insurance coverage the family already has and verifies that information with the employers and record matches under regular Medicaid TPL procedures. The state also looks at the number of recipient children who would have been

SCHIP eligible, but were enrolled under Title XIX because they had insurance coverage. The state generates a report that separates children who have third party coverage from those who do not. Children without coverage go into SCHIP, while children with coverage are put into regular Medicaid, so that appropriate match is drawn.
