

Performance Year 2024 APM Performance Pathway: CMS Web Interface Measure Benchmarks for ACOs

Introduction

This document describes the methods to calculate the quality performance benchmarks for the CMS Web Interface measures for the 2024 performance year.

Quality performance benchmarks for measures reported via the CMS Web Interface are generally established by CMS prior to the performance year for which they apply. In the 2024 performance year, under the Alternative Payment Model (APM) Performance Pathway (APP), Accountable Care Organizations (ACOs) participating in the Medicare Shared Savings Program have the option to report on 10 CMS Web Interface measures, 3 electronic clinical quality measures (eCQMs), 3 Merit-based Incentive Payment System (MIPS) clinical quality measures (CQMs), or 3 Medicare CQMs. ACOs must also administer the Consumer Assessment of Healthcare Providers and Systems (CAHPS) for MIPS survey and will be assessed on two administrative claims measures calculated by CMS. This document only describes the quality performance benchmarks that will apply for the CMS Web Interface measures in the 2024 performance year.

Benchmark Data Sources

We established the 2024 quality performance benchmarks for the CMS Web Interface measures using all available and applicable 2020, 2021, and 2022 Medicare fee-for-service (FFS) data. This includes:

- Quality data reported by Next Generation Model ACOs through the CMS Web Interface for the 2020 and 2021 performance years;
- Quality data reported by Shared Savings Program ACOs through the CMS Web Interface for the 2020, 2021, and 2022 performance years; and
- Quality data reported through MIPS by physicians and groups of physicians through the CMS Web Interface or claims for the 2020, 2021 and 2022 performance years.

The quality performance benchmarks were calculated using ACO, group, and individual clinician data aggregated to the practice or Taxpayer Identification Number (TIN) level. These calculations include TIN-level data if the TIN had at least 20 cases in the denominator for the measure. Quality data for ACOs, groups, and individual clinicians that did not satisfy the reporting requirements of the Shared Savings Program or MIPS are not included in the calculations of the benchmarks.

Benchmarks for CMS Web Interface Measures

Benchmarks for the CMS Web Interface quality measures for the 2024 performance year are specified in the **Appendix**.

A quality performance benchmark is the performance rate an ACO must achieve to earn the corresponding quality points for each measure. We show the benchmark for each percentile, starting with the 1st percentile (corresponding to the minimum attainment level) and ending with the 90th percentile (corresponding to the maximum attainment level).

³ We note that Statin Therapy for the Prevention and Treatment of Cardiovascular Disease (Quality ID# 438) and Depression Remission at Twelve Months (Quality ID# 370) do not have benchmarks and therefore will not be scored for the 2024 performance year; they are, however, required to be reported in order to complete the Web Interface dataset.
