SUBJECT: New Composite Payment Rates Effective April 1, 2001, through December 31, 2001, and the Application of Exceptions Under the End Stage Renal Disease Composite Rate System

I. CURRENT COMPOSITE PAYMENT RATES

On December 12, 2000, we issued a Program Memorandum (PM) under Transmittal A-00-94 (Change Request 1451) which gave notice of a 1.2 percent increase to the composite payment rates effective January 1, 2001. The 1.2 percent increase was mandated under §222 of the Medicare, Medicaid, and SCHIP Balanced Budget Refinement Act of 1999 (BBRA). These rates are effective for treatments furnished January 1, 2001, through March 31, 2001.

II. NEW COMPOSITE PAYMENT RATES

Section 422(a)(1) of the Benefits Improvement and Protection Act of 2000 (BIPA) provides for a 2.4 percent increase to the composite rates effective January 1, 2001, in lieu of the 1.2 percent provided in BBRA. In order to avoid the need for retroactive processing of bills caused by the January 1, 2001, effective date of the 2.4 percent composite rate increase, §422(e) specifies that the increase will be implemented through the application of two composite payment rates in 2001. For outpatient dialysis treatments furnished on or after January 1, 2001, through March 31, 2001, the 1.2 percent increase provided under BBRA and set forth in Tables I and II in Transmittal A-00-94 will apply. For services furnished April 1, 2001, through December 31, 2001, a 2.79 percent increase, reflecting a transition adjustment of .39 percent, is applicable. In this manner, providers will be given the required overall 2.4 percent increase to the composite rates for all of 2001. Upon expiration of the 2.79 percent transition rate, effective January 1, 2002, the composite rates will revert to those in effect December 31, 2000, increased by 2.4 percent.

Tables I and II of this transmittal list the new composite payment rates for renal dialysis facilities in urban and rural areas effective April 1, 2001, through December 31, 2001, and reflect a 2.79 percent increase from the rates in effect on December 31, 2000. This 2.79 percent update increases the payment ceiling to \$144.59. Beginning April 1, 2001, through December 31, 2001, do not pay any renal facility more than \$144.59 unless it has an approved exception payment rate.

Tables III and IV contain the composite payment rates for renal dialysis facilities in urban and rural areas beginning January 1, 2002, and reflect a 2.4 percent increase from the rates in effect on December 31, 2000. This 2.4 percent update revises the payment ceiling to \$144.05. Beginning January 1, 2002, do not pay any renal facility more than \$144.05 unless it has an approved exception payment rate.

Effective April 1, 2001, the payment rates in Tables I through IV supersede those contained in our PM issued December 12, 2000, under Transmittal A-00-94. They remain in effect until new payment rates are issued.

III. APPLICATION OF CURRENT EXCEPTION RATES

In accordance with §422(a)(2) of BIPA, this rate change will NOT result in the opening of a new exception cycle. This section provides that exception rates in effect on December 31, 2000, will continue in effect so long as the exception rate exceeds the updated composite payment rate. This means that an exception rate granted as a result of the last exception cycle which closed on August

28, 2000, would be retained by a renal facility if the approved exception rate is higher than the updated composite payment rate effective April 1, 2001. We note that adjudication of these exception requests was completed November 22, 2000.

IV SUBMISSION OF NEW EXCEPTION REQUESTS

Section 422(a)(2)(B) of BIPA also provides for the submission of new exception requests in the case of a facility that did not file such a request during 2000. The statute requires that all such applications be submitted by no later than July 1, 2001. This means that facilities that did not request retention of a previously approved exception amount or did not file a new exception application in 2000, may submit an exception application no later than July 1, 2001. If approved, exception rates will be applied beginning with the date the first complete application was received by your office. Do NOT accept exception applications from any facility with a current exception rate or that filed an exception application during 2000.

V. INTERMEDIARY INSTRUCTIONS

By no later than March 15, 2001, provide written notification to **each** renal facility you service of either its new transitional composite payment rate for the period April 1, 2001, through December 31, 2001, or retention of its exception payment rate, if higher. For any renal facility that has an approved exception rate that exceeds the new composite payment rate for its area, this notice must state that the facility will continue to receive the exception rate. Also, inform each facility that beginning January 1, 2002, the composite rate will reflect a 2.4 percent increase over the rate in effect on December 31, 2000.

Also, notify each facility that does not have a current exception rate and did not file an exception application during 2000, of the opportunity to submit a request for an exception to its composite payment rate. The statute specifies that new exception applications must be submitted no later than July 1, 2001. However, since July 1 falls on a Sunday, you may accept applications that you receive by the close of your regular business hours on July 2, 2001. HCFA will adjudicate these exception requests in accordance with the exception criteria set forth in 42 CFR 413.180 and PRM, Part I, Chapter 27.

Delivery of exception requests must be accomplished through a method which documents the date of receipt. HCFA will deny any request for exception which is not received by your close of business on July 2, 2001. Neither HCFA nor you may extend this filing deadline. Do NOT accept any exception requests from facilities that have a current exception or filed an exception request during 2000.

If you return a facility's exception application because it is incomplete, the facility must resubmit a complete request to you by July 2, 2001.

We are reminding you of your responsibilities for processing and controlling ESRD exception requests as outlined in §2723 of PRM, Part I. These responsibilities include, but are not limited to the following:

- o Reviewing for completeness and accuracy the exception request, the cost report, the facility's projected costs, and any other documentation submitted by the facility to support its exception; and

o Maintaining an exception log. Because of the statutory deadline that an exception request is deemed approved unless we disapprove it within 60 working days (15 working days for the intermediary and 45 working days for HCFA), it is essential that all exceptions be processed timely. In order to track the start of the 60 working day requirement, intermediaries must call central office (CO) the day an exception application is received. The telephone number in CO is (410) 786-4533. Provide the following information: (a) Name and provider number of the renal facility; (b) The date the exception is received; (c) The type of exception; (d) The amount requested; and (e) The telephone number and contact person at the intermediary.

NOTE: Pay all claims for dialysis services rendered on or after April 1, 2001, through December 31, 2001, using the composite payment rates listed in Tables I and II, unless the facility has an approved exception rate that is higher.

Pay all claims for dialysis services rendered on or after January 1, 2002, using the composite payment rates listed in Tables III and IV, unless the facility has an approved exception rate that is higher.

The *effective date* for the PM is April 1, 2001.

The *implementation date* for this PM is April 1, 2001.

These instructions should be implemented within your current operating budget.

This PM may be discarded after December 31, 2004.
