SUBJECT: Update to Data Posted on Nursing Home Compare Website

TO: Associate Regional Administrators, DMSO
State Survey Agency Directors

This memorandum is to provide you with information on the imminent introduction of complaint data on the Centers for Medicare & Medicaid Services (CMS) Nursing Home Compare website (<http://www.medicare.gov/NHCompare/home.asp>). We expect the website to include this new information beginning on or around May 7.

As a result of recommendations made in a Congressional report on survey data posted on Nursing Home Compare, CMS will be expanding the survey data currently posted to include health deficiencies cited as a result of a complaint investigation. Currently, we report only health deficiencies that are cited during the standard survey.

There is a slight overlap between standard survey and complaint survey deficiency findings. As a result, deficiencies found on both a complaint and standard survey, i.e., those that have identical tags, scope and severity, and deficiency dates within one month of each other will appear only once on the website.

The link to "Inspection Results" will lead to information that includes complaint deficiency citations as well as deficiencies cited during a routine survey. We are changing the display of deficiency data slightly (see attached example). Nursing Home Compare will display deficiency data with the date of the citation underneath the deficiency description in the first column of the chart. This identifies the date the deficiency was cited and will also let consumers identify those deficiencies that were cited during the standard survey from those cited during a complaint investigation. Dates that do not reflect the date of the last inspection are deficiencies cited as a result of a complaint investigation.

In addition to the date of the last inspection, complaint deficiency citations will be displayed by calendar period. For example, when a website viewer selects the most recent survey results, complaint deficiencies cited during the previous 15 months will be displayed. When the viewer selects the first prior survey, complaint deficiencies cited 16 to 28 months previously will be displayed.

We believe these changes will improve the quality of data we provide to website viewers. We welcome any comments you might have about these changes.
