I. GENERAL INFORMATION

A. Background: Transmittal 23, issued May 6, 2007 (Change Request (CR) 3862), Procedures for Modifying Shared System Edits and Capturing Audit Trail Data initiated the Fiscal intermediary (FI) Edits Evaluation Workgroup. The FI Edits Evaluation Workgroup is tasked with identifying the inventory of contractor inactivated edits, documenting the reasons why the edits are turned off, and making a decision as to whether they should remain inactive or not. Since the inception of the workgroup, CMS has issued numerous Joint Signatures Memorandums (JSMs) providing the national CMS standard for thousands of reason codes within the FISS.

The progress made within the FI Edit Evaluation Workgroup led to the issuance of Transmittal 338, (CR 5927), Shared Systems Active and Non-Active Edits/Reason Codes and Audit Trail Reporting on May 2, 2008.

The purpose of this CR is to automate the process of loading the CMS Standard for each reason code reviewed by the FI Evaluation Workgroup within the FISS.

Each quarter, CMS will issue an updated CMS Standard File for Reason Codes, which will be used to determine what the appropriate status shall be for each code.

B. Policy: This instruction describes the process for updating the CMS Standard File for Reason Codes.

(Rev.59, Issued: 10-30-09, Effective: 04-01-10, Implementation: 04-05-10)

The FI Edits Evaluation Workgroup is tasked with identifying the inventory of contractor inactivated edits, documenting the reasons why the edits are turned off, and making a decision as to whether they should remain inactive or not. Transmittal 338, (Change Request (CR) 5927) issued on May 2, 2008, created the 'CMS Standard' field within the existing FISS Reason Code File which contains the status that was determined by the FI Edits Evaluation Workgroup for each individual code that was reviewed. The 'CMS Standard' field indicators are as follows:

- 'A' = Active
- 'I' = Inactive
- ' = Blank

NOTE: The terms 'Active' & 'Inactive' are defined as:

- Active = Reason code status is equal to 'S', 'P', ' (blank), 'D', 'R', 'T', or is not equal to 'S MDLTD'; and
- Inactive = Reason code status is equal to 'A' or is equal to 'S MDLTD.'

Each quarter, as necessary, CMS will issue an updated CMS Standard File for Reason Codes which is loaded into the system by the FISS maintainer via a Recurring Update Notification.
