**A. Background:** This instruction updates Pub. 100-04, chapter 13, section 60.3.2 to include two new HCPCS codes for radiopharmaceutical diagnosis imaging agents (tracers). Effective 1/1/06, A9555 replaces Q3000 and A9552 replaces C1775. HCPCS codes Q3000 and C1775 are deleted effective 12/31/05.

**B. Policy:** No change in policy. This instruction simply updates current radiopharmaceutical diagnosis imaging agents applicable to PET scan services.
